#### ABOUT THE OPPORTUNITY

This is a full-time exempt level position in Mountain View, California.

Like many employers, SVCF has pivoted to a mostly remote workforce during the pandemic. However, once there is a return to office, the expectation is that staff will be based out of our headquarters in Mountain View, California.

#### JOB SUMMARY

Reporting to the Vice President, Strategic Initiatives, the Director, Housing is responsible for advancing Silicon Valley Community Foundation's strategic priority to ensure Silicon Valley is a place where everyone has access to safe, dignified and affordable housing. The Director will design, execute and help fundraise to implement high impact strategies that close the gap between the need for and availability of housing that is affordable for extremely- or very low-income people.

#### **IDEAL CANDIDATE**

The ideal candidate possesses:

- Deep expertise in housing production of new housing, preservation of affordable housing and protection of tenants.
- Has centered racial justice in work experience with an intentional focus on people of color and low-income populations.
- Experience in community organizing and public policy.
- Knowledge of the Silicon Valley housing landscape.

### RESPONSIBILITIES

- Fund housing approaches that can be strategically employed to bring relief to residents most impacted by the affordability crisis and over time lead to ownership opportunities and long-term affordability (e.g., provide general operating and capacity building grants to organizations that preserve and produce housing that is affordable for extremely low income and very low-income families).
- Fund community investment models that attract and deploy capital to support affordable housing preservation and production (e.g., partner with others to launch a
  preservation and/or development loan fund).
- Build relationships and partnerships with institutional funders and raise resources to fund strategic housing initiatives.
- Deploy a range of proactive, creative donor engagement strategies to spur increased giving toward affordable housing organizations and movements in Silicon Valley and raise resources to support SVCF housing initiatives.
- Launch an initiative to support community residents specifically BIPOC- to organize and advocate for housing policies that positively impact their lives, focusing on (1) mid-Peninsula cities that historically have not met their established goals for affordable housing production and (2) cities where displacement risks are high.
- Launch a strategic storytelling campaign that elevates the voices of those affected and helps drive change; facilitate sharing of key lessons learned across neighborhoods and organizations
- Continue support of policies that advance production and preservation of affordable housing as well as that protect residents from displacement. Monitor state and local policy windows to advance the policy agenda.
- Continue engagement and leadership in key local initiatives such as the Partnership for the Bay Area's Future and Great Communities Collaboratives.

- Focus SVCF research to address knowledge gaps / opportunities surfaced by key actors in the field, especially regarding housing needs for BIPOC, extremely and very low-income populations.
- Organize and staff an advisory group that will meet periodically to provide strategic guidance to the housing work.
- Assess funding needs for initiatives and special projects; actively pursue funding through grant-writing and other fundraising activities.
- · Provide updates, reports, and other communications to Vice President of Strategic Initiatives.
- Promote an atmosphere of teamwork, enthusiasm and commitment.
- Attend and participate in appropriate joint efforts and leadership groups, conferences, events, networks of foundations and community partners to establish
  significant positioning of SVCF in the affordable housing field.
- Other related duties as assigned.

## **QUALIFICATIONS and SKILLSETS**

- Bachelor's degree required.
- 10+ years relevant professional experience.
- · Demonstrated track record of setting clear priorities and success in driving a strong, results-oriented agenda and strategy.
- A strong understanding of the housing landscape, including current legislative climate, political ecosystem.
- Commitment to social justice and community impact.
- · A track record of developing and maintaining strong working relationships with internal partners and external stakeholders.
- Excellent organizational, management and communication skills.
- · Very strong verbal and interpersonal skills.
- Commitment to quality, results and superior performance.
- Collaborative work style; able to facilitate amongst diverse communities and individuals; able to resolve conflict when key stakeholders having differing points of view.
- · Excellent analysis, writing, editing and speaking skills.
- Strength in managing multiple, complex priorities often with tight deadlines.
- · Ability to approach situations and challenges with a sense of humor.
- · Keen interest in philanthropy and the non-profit community.

#### WORK ENVIRONMENT AND PHYSICAL DEMANDS

While performing the duties of this job, the employee is regularly required to sit; use hands to finger, handle, or feel objects, tools or controls; reach with hands and arms; and talk or hear. The employee must regularly lift and/or move up to 10 pounds. Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception, and the ability to adjust focus.
