SV@Home is a 501(c)(3) nonprofit housing advocacy organization whose mission is to advance systems change to achieve housing affordability and housing justice. POSITION OVERVIEW

SV@Home is seeking two (2) detail-oriented Housing Justice Interns that are interested in learning more about local, regional, and state housing policy to support our policy and advocacy work through a 10-week summer internship. Both interns will work closely with the Executive Director and the Housing Policy Team to provide substantial administrative support. The Housing Policy Intern will be exposed to many facets of SV@Home's Housing Policy and Advocacy efforts including, coalition building, research and data analysis, community-based training, and knowledge-sharing. This is a Full-Time, Temporary, Non-Exempt position that reports to the Leadership Development Program Manager.

KEY DUTIES AND RESPONSIBILITIES

The Housing Justice Intern will be responsible for the following activities:

- Complete and present a culminating capstone project integral to SV@Home's policy and/or programmatic priorities;
- Conduct research & analysis, data entry, and summarize literature on different topics related to local, state, and regional housing policies;
- Identify, attend, and take notes on internal and external events (both virtual and in-person) relevant to the work of SV@Home;
- Support the housing policy, leadership development, and/or communications teams with regularly updating the SV@Home website with resources and other information as needed:
- Provide programmatic support for SV@Home events, workshops, and trainings;
- Perform a variety of communications, administrative, and logistical tasks as needed.

EXPERIENCE AND QUALIFICATIONS

A competitive candidate will have the following experience, knowledge, and attributes:

- Professional, academic, or personal interest in affordable housing policy;
- A passion for social change and a commitment to equity;
- Advanced proficiency with Microsoft Office Suite;

- Must be detail-oriented, well-organized, with the ability to manage multiple projects & priorities simultaneously;
- Ability to work in a team environment;
